☐ Complete application online: https://southlands.wufoo.com/forms/wazmkmu1kmtwxd/ ☐ Pay \$250 application fee online ☐ Upload official transcript of most recent years -High school applicants are required to upload all transcripts from 9th grade. -11th/12th grade all transcripts from 9th grade must be uploaded for evaluation in advance Upload passport copy Online Zoom interview: Must download Zoom on a computer Evidence of English Proficiency (TOEFL/IELTS/Duolingo/TOEFL Jr.): Depends on the grade applied **Step 2 – I-20 Processing (After Acceptance)** ☐ Provide Evidence of Funds: (No less than \$60,000) Pay a \$650 I-20 processing fee and a \$10,000 Reserved Seating Security Deposit. -The deposit amount may vary after the application deadline July 1st The I-20 form will be sent to the parents and/or guardians only (Printed I-20 electronic copies are currently accepted for visa interviews and U.S. entry. If policies change and an original I-20 is required for in-person interviews, a \$130 mailing fee will apply.) Step 3 – F1 Visa (Action Relating to Embassy/Consulate) Pay I-901 Fee Online at: https://www.fmjfee.com/i901fee/index.html ☐ Schedule appointment with the U.S Embassy for F1 Visa (must bring F20 Form & proof of F901 fee payment) Provide the visa appointment confirmation letter within 7 days of receiving the I-20. ☐ The following circumstances will result in the cancellation of the I-20: -Non-submission of the visa interview confirmation letter within 7 days. -Provision of inaccurate, false, or outdated visa interview information. -Visa rejection; (in case of denial, timely communication with the school is necessary for reapplication.) **Step 4– Actions after Passing the Visa Interview** Pay tuition and registration fee within one week after the visa is granted ☐ Complete the online registration enrollment system Powerschool, where all documents are signed and uploaded within the system. Provide an F1 Visa copy & arrival date to the International Admissions Office ☐ Attend mandatory placement exam day and orientation □ Students can only start classes after completing all immunizations and submitting all required documents. All fees are subject to change All fees are non-refundable The \$10,000 reservation seat deposit is refundable solely with the latest valid official rejection proof
